1. The MCDF Coordination Committee received an update by the CEO of the MCDF Secretariat on recent developments at MCDF.
2. The MCDF Coordination Committee received a briefing by the MCDF Secretariat on the activities of the MCDF Collaboration Platform since the last MCDF Coordination Committee meeting and planned future activities.
3. The MCDF Coordination Committee held a discussion on innovations in road public-private partnerships (PPPs). The Ministry of Transport of Colombia, Colombian Chamber of Infrastructure, Development Bank of Latin America and the Caribbean (CAF), and National Development Finance Corporation of Colombia (FDN) shared their reflections.
4. The MCDF Coordination Committee received an introductory presentation from the East African Development Bank.
